Belmont Abbey College is please to be able to continue the tuition deferment program for students who are eligible for employer reimbursement for the summer 2011 semester.

If you would like to participate in this program during the summer 2011 semester, please submit the following information by the dates outlined below:

- ✓ Complete the enclosed Tuition Deferment form and return to Diane Hinson (704.461.6710) in the Student Financial Services Office.
- ✓ Obtain signed authorization from management of your employer to enroll in summer classes and submit your completed company's tuition reimbursement form to Diane Hinson (704.461.6710) in the Student Financial Services Office.
- ✓ Submit a copy of your company's policy regarding tuition reimbursement.
- ✓ Return all of these items no later than **May 14, 2011**.

You will need to forward to the Student Financial Services Office, the amount your employer will not reimburse no later than May 14, 2011. If your payment is late, you will be assessed a \$300.00 late charge.

Payment of deferred charges for the summer 2011 semester is due no later than August 17, 2011. Payment of your account while on the Tuition Deferment Program is your responsibility, not the responsibility of your employer or the College. If payment is not received by August 17, 2011, you will be charged a \$300.00 late fee; your fall 2011 class schedule will be cancelled and may no longer be eligible for the tuition deferment program.

## BELMONT ABBEY COLLEGE TUITION DEFERMENT PROGRAM SUMMER 2011

employer's reimbursement policy. I further acknowledge that I am responsible for paying  
any amount not covered by my employer's reimbursement policy by May 14, 2011.

I understand that if I do not meet the requirements for reimbursement from my employer  
or withdraw from any course or from the college, that the balance due on my account is  
payable in full within five (5) days of such action. ***I understand if in the event my  
employer decides, for any reason, not to pay the balance on my account, I am  
responsible for the entire amount.***

I further understand that payment in full of my account is my responsibility and that  
payment is due no later than **August 17, 2011** and that my company will be notified of  
failure to make payment under the policy guidelines of my employer reimbursement  
program. I understand that failure to pay by August 17, 2011, may result in cancellation  
of my fall schedule, a \$300.00 late fee and that I may no longer be eligible to participate  
in the tuition deferment program at Belmont Abbey College.
